PLGC Terms and Conditions for Member Participation

- 1. ALL Members must check in to the Golf Shop prior to play. Pine Lakes GC reserves the right to make alternative tee time considerations for tournaments, special events and out-of-town guests.**
- 2. Our tee times are valuable inventory. If you are not going to use your tee time or will have less players than reserved, Members must notify the Pro Shop, so that these openings can be made available to another member or guest. If a member consistently fails to call the Pro Shop to cancel a tee time after we have reminded him of this policy, a repetitive "no show or late cancellation" fee of \$10 per incident will be charged. These Fees are not applicable if course is deemed unplayable or in instance of severely inclement weather conditions.**
- 3. Golf Cart rules will be established on a day-to-day basis. When we are Cart Path Only this applies to ALL MEMBERS WITH NO EXCEPTIONS. Golf Carts must stay on cart paths around all tees and greens and park with all four wheels on the cart path. Members must observe all cart directional signs and roped off areas. Failure to do so may result in a warning or suspension of playing privileges. If the group in front of you is not obeying cart rules, please notify the Pro Shop.**
- 4. Please repair ball marks, sand divots and rake bunkers so that you will want to play the course again next week.**
5. PLGC reserves the right to host tournaments/outings which are not open to the public or Members. PLGC reserves the right to close any and all areas of the golf course as it deems necessary.
6. Use of the Golf Course and Practice Complex shall be at Member's risk and responsibility and Member agrees to hold Pine Lakes GC harmless from any claims, losses, or damages sustained by Member in the course of its participation or activities on the Golf Course or at the Practice Complex. Each member as a condition of membership and each guest a condition of invitation to the Club facilities assume sole responsibility for his or her property. In the event Member shall directly or indirectly cause damage or loss to Pine Lakes GC, including its facilities and properties, through negligence or by intentional misconduct, Member shall be liable to Pine Lakes GC for any such costs and damages, as well as any legal fees that may be incurred by Pine Lakes GC.
7. Member agrees to abide by all PLGC rules, regulations, policies & procedures. PLGC reserves the right to implement & enforce all operational policies, i.e. dress code, personal conduct, staffing, capital improvements, conditions of course/practice areas and proper etiquette. Members & guests must follow and adhere to all rules & regulations set forth by PLGC. Any rules violations may result in suspension or revocation of membership. Should a member be suspended or membership privileges be revoked, there will be no prorating or refund of dues paid. PLGC reserves the right to revoke membership privileges for misconduct and failure to follow club rules and regulations and failure to respect the facility, our employees and our guests.
8. Except as expressly provided herein, payments and fees for participation in the Membership are non-refundable.
9. No more than four players may play as a group unless specific authorization is granted from the Pro Shop Staff.
10. It is the player's responsibility to be informed of and knowledgeable of the rules and regulations of the club.
11. Faster players must be allowed to play through if there is a clear hole open ahead of your group.
12. Except as expressly provided herein, payments and fees for participation in the Membership are non-refundable.
13. Requests for a Medical leave will be considered on a case by case basis when required documentation is provided. Medical leaves must be over 3 months long & the member may not play golf during the period for which the leave is granted. . A medical leave credit that is approved must be applied towards the following years membership or it will be expired. There is a maximum of 2 medical leave credits that may be issued to any member during the lifetime of their membership.
14. Members are required to ride in a cart as twosome. Two members may not go out in separate carts if playing together.

By signing below, Member agrees to all the terms stated below and further agrees that any outstanding payments, fees or charges owing to Pine Lakes GC by the Member shall be charged to the credit card above without any further notice. And, by signing below I hereby acknowledge that participation or use of Pine Lakes GC has inherent risks of injury and I fully accept any and all risk of injury to myself or my guests sustained while using any of the facilities. In accepting the risk of injury I understand that I am relieving Firinn Golf Group of VT, LLP its managers, partners and employees and affiliates of liability. I also agree that I will not allow anyone under the age of 16 yrs of age and not in the possession of a valid driver's license to operate any of the facilities golf carts. I assume full responsibility for damages incurred to the cart or property as a result of my operation of the golf cart and authorize Pine Lakes GC to bill the cost of any repairs to the credit card indicated above upon my receipt of an itemization of said damages.
